Rules and Regulations

The Black Stork in Siedmica

We cordially welcome you to our Black Stork hunting lodge in Siedmica and we wish you a peasant stay here. We will be grateful for complying with the rules included in the following document the purpose of which is to ensure peace and safety of our guests. Thanks to the mutual co-operation we hope to avoid any unnecessary misunderstandings.

This hunting lodge belongs to Jawor Forest Inspectorate. The person who is responsible for your stay here is Tomasz Karp, the forester of this forest district. He lives in this lodge and he is available at the following phone numbers:

- 1. The check in time is 2 p.m. on the day of your arrival and the check out is at 12 noon on the day of your departure.
- 2. You can book a room at the following phone numbers: 76/871 16 00 or 76/871 16 33 as well as by writing to this email address: jawor@wroclaw.lasy.gov.pl
 The reservation is then confirmed by the worker of Jawor Forest Inspectorate.
- 3. To make a booking with us, you must make the down payment of 30 per cent of the total price for your stay. The money should be sent to the following bank account:

BGZ 71 20300045 1110 0000 0012 2890 within 2 days of the date of reservation.

- 4. As soon as the down payment is made, your reservation will be confirmed by a phone call or email sent by our staff.
- 5. Guests are requested to pay the remaining fee on the day of their arrival in cash or by bank transfer (see the bank account above).
- 6. In case of your cancellation of the reservation, no fee will be charged on condition that we are informed at least 2 weeks prior to your expected arrival. The money will be paid into your personal bank account.
- 7. In case the reservation cancellation is not submitted within the established deadline, i.e. in less than 2 weeks before arrival, your down payment will not be refunded.
- 8. Guests can book a room without advance reservation provided there some vacancies in the lodge. This booking refers to the period shorter than 3 days before your arrival. In this instance, guests are required to make their total payment upon check in.
- 9. Extension of stay at the Black Stork lodge is subject to room availability. When the date of your extended stay is agreed upon with the forester, you must make the payment on the first day of extension.
- 10. Guests are obliged to check in upon arrival at the person indicated above. They are required to present a valid document with a photograph to verify their identity.
- 11. At check in guests obtain their room keys, a key to the main entrance door along with the gate remote control all of which should be returned on the day of their departure.
- 12. It is obligatory for all guests to lock their rooms and the main entrance door when leaving the lodge.
- 13. Guests shall bear the cost of duplication of their lost keys.
- 14. Parking is limited to specific lots indicated by the forester.
- 15. The lodge owner bears no responsibility for any damage to cars in the parking lot.

- 16. Guests are allowed to prepare their own meals in a specially designated area called 'the kitchen for guests'.
- 17. All guests using the kitchen must keep that place clean and tidy.
- 18. The lodge offers you sauna and billiards table which can be used between 12 p.m. and 10 p.m. Advance arrangements with the forester are required.
- 19. Guests willing to use sauna should familiarize themselves with the instructions placed on the wall of corridor leading to sauna.
- 20. Smoking is prohibited in the lodge, except for specifically designated area on the terrace.
- 21. Valuables can be deposited and kept in special metal lockers. You can obtain the key from the forester after check in.
- 22. Guests are requested not to leave their children unattended. During your stay at the Black Stork parents take full responsibility for the security of their offspring.
- 23. Meals are served at the following times:

breakfast - from 8 a.m. until 11 a.m. lunch - from 1 p.m. until 3 p.m. dinner -from 6 p.m. until 8 p.m.

- 24. It is possible to arrange individual meal times with the forester.
- 25. Guests who participate in hunting can store their weapon in specially designated cabinets. The keys can be obtained at check in.
- 26. All rooms are cleaned every day. Towels are exchanged every 3 days. Bedding is exchanged every 7 days.
- 27. In case of damage, quests are required to pay compensation to fully cover the value of losses. Any damage should be reported immediately to the forester.
- 28. We kindly request our guests to keep their rooms and common areas clean and tidy at all times. They are also asked to observe nighttime peace and quiet in the period from 10 p.m. to 6 a.m.
- 29. All guests must comply with the above rules as well as work safety regulations, the fire safety regulations and they must follow the forester's instructions in case of emergency.
